

## Board Changes

The following board changes, effective June 1, 2017, have occurred by recommendation of the Court Improvement Program (CIP) at the Administrative Office of the Courts (AOC):

Bd. #1— from 16-17 year olds to 17 year olds ONLY

Bd. #4— from 16-17 year olds to 17 year olds ONLY

Bd. #5—from 16-17 year olds to 17 year olds ONLY

Bd. #7— from 14-15 year olds to 14-16 year olds

Bd. #11— from 16-17 year olds to 14-16 year olds

Bd. #16—from 14-15 year olds to 14-16 year olds

This was based on data collection that showed 36% of the youth in Davidson County foster care were 17 year olds and hence needed 3 boards to review their cases. Also, the peer advocates provided by the CIP, will only attend the 17 year old boards and the EFC boards from now on. This is all in an effort in improve Transitional Living for youth aging out of foster care and for those youth who will transition into Extension of Foster Care (EFC). If you feel you need to move to another board due to these changes just let us know and we will work with you! Thank-you for your patience and understanding.

\*Please note that the majority of the youth who do not attend is due to factors beyond DCS's control such as being on runaway, in detention, can't miss school or special events, illness, etc.

## Transitional Living Plans (TLs)

#### LEARNING CORNER

All Youth in DCS custody will have an Independent Living Plan at ages 14 to 16 or a Transition Plan at age 17 and older regardless of permanency goals, placement or adjudication. The Transition Plan must be developed when the youth is 17 years of age or older, within the context of a Transition to Adulthood CFTM. The Transition Plan is <u>revised as needed</u> and reviewed by the court within ninety (90) days of planned exit from custody.

The Transition Plan is completed using IL Concern indicators associated with the Family Permanency Plan. The focus of the Transition Plan is ensuring that supports are in place for youth following exit from custody at ages 17 and older. The following areas are addressed in the Transition Plan:

🛮 Life Skills
🛘 Social Skills and Supportive Relationships
Communication, including Essential Documents
Education
$\hfill \square$ Physical and Mental Health, including identification of a Health Care proxy
Employment
□ Housing
☐ Finances and Money Management
☐ Transportation

The Transition Plan <u>must be personalized</u> at the direction of the youth, be as detailed as he or she chooses, and include specific outcomes and <u>action steps with timeframes</u>.

The Transition Plan/Family Permanency Plan is signed by all parties and copies are provided to the youth and other individuals involved in the development of the plan. The Transition Plan is filed in accordance with filing requirements for the Family Permanency Plan.

The assigned FSW is responsible for ensuring that the Transition Plan is revised at least annually and more often as needed.

The Transition Plan is reviewed in a CFTM at least semi-annually. Transition Plans are <u>reviewed</u> by the court or a representative of the court annually and <u>by the Foster Care Review Board on a semi-annual basis</u>.
