With so many board members having resigned over the last year, and not as many as resigned joined we have had to send many emails for subs. You all have stepped up and for that we here at Juvenile Court are immensely grateful. If for some reason you are not able to attend your designated board time please notify us as soon as you possibly can. If you are able to volunteer on a day that you do not normally do please contact one of the court facilitators, or Teresa and we will let you know the scheduled boards.

We had hoped to start a new board in June to help with the 5-13 age group, they have the heaviest load of all the boards. Unfortunately we have not had enough new volunteers. We are now set to start in July, and it will be the 2nd Thursday @12:00 email me if interested

Many of you know that the school documentation is one of the biggest problems we have in making sure the youth are on track to graduate, and are getting the appropriate services while in care. Well I have good news. The AOC, MNPS, DCS, and the Court have been working on a joint project that will kick off July 1, and actually start having an impact with the beginning of this upcoming school year. MNPS is going to have a coordinator for each school quadrant that will meet with DCS to help with school transitions, their appropriateness, the completeness of records, and above all the BEST INTEREST decision making for school placement changes! Residential treatment changes as they step into or out of a metro school will also be part of this pilot.

From the desk of the Chief

I must say over the past 10 months I have learned a lot about Foster Care Review Boards (FCRB) from the court's perspective. As I think most of you know, up until 10 months ago, I was working for DCS for the past 20 years. Working in Foster Care (FC), Juvenile Justice (JJ), Quality Control, and Child Protective Services (CPS); however at some point I was involved with either presenting or representing my staff at the boards.

This week, I was presenting this week to a group of DCS CPS workers at the TBI office in Nashville on "Engaging Teen Males". It was an interesting discussion on trying to relate to teens. They can be combative, mis-read facial cues, quick to anger, and unyielding in their beliefs if and when they feel they have been "wronged" in some way. I pondered the question, "If we all do not feel or react that way sometimes?" I must acknowledge that I do; as I think we all do when a FSW cannot answer the questions or when a child is late for the review. Just as when a board does not have a quorum and we have to re-schedule it.

FCRB's are an integral part of the foster care system as you function as the eyes and ears of the court. Like I explain to our staff here at court, building relationships takes time, effort, and a lot of patience. Amy Warner, UC Berkley, conducted a 40 year longitudinal study and followed 400 babies into their adulthood. She found that 2 protective factors were most important in helping youth meet their fullest potential. The first was meaningful relationships and the second was spiritual beliefs.

Meaningful relationships is what the FCRB and DCS should be developing to work in the best interests of children. As with most relationships they can be hard and hurtful but they can also be powerful and supportive. I prefer powerful and supportive. To get there we have to believe the relationship is worth the time and investment. Our youth are worth that time and investment.

I look around at FCRB's and see such dedicated Volunteers and staff as well as dedicated and sometimes overwhelmed staff at DCS, who really want what is best for kids and their families. We can just tend to see things a little differently sometimes. Make no doubt, we have a strong meaningful relationship between the FCRB's and DCS and it is working. We can make it stronger if we remember all relationships have a give and take, then we can take steps towards that goal together; Permanency for our youth!

In closing, no way can anyone thank you Board Members enough for your sacrifices, but I must start by saying, Thank You! Thank you for your time, energy, frustrations, joy, and most of all, thank you for building relationships with our youth, families, court staff and DCS.
